

Rules of residence in dormitories of Andijan State Medical Institute

1. Students are given the right to reside in the university dormitory only for the period of study. Being a university student is the only reason why you can live in a hostel.
2. Each student must have and carefully store the key in the dormitory of the established model. Entrance to the hostel is allowed only through the central entrance and the security point.
3. Each student is obliged to pay for accommodation in the hostel in a timely manner.
4. If the tenant does not plan to live in the hostel for a long time, he is obliged to inform the director of the campus about this.
5. If there are objective reasons and by the decision of the Administration, the tenant must move to another room of this or another hostel of Uni University.
6. Tenants are obliged to thoroughly study the main regulatory documents of hostels and put their signature on them.
7. The hostel operates in accordance with the norms and principles of the civil Russian State, so any discrimination on the basis of sex, racial, national, religious, ideological, religious affiliation, etc., is strictly prohibited, and the person acting in this way is subject to eviction from the hostel.
8. It is necessary to behave calmly, politely and politely in the hostel, to avoid screaming, rude, obscene expressions and manifestations of all forms of violence and aggression. In the period from 22.00 to 8.00 in the hostel should observe silence.
9. In the hostel, drinking, intoxicated, smoking (including hookah smoking and e-cigarettes) is strictly prohibited, as well as drug use and being intoxicated.
10. Each tenant is obliged to maintain his living room clean and in order. He/she must also clean the room daily and clean the trash. The student must perform wet cleaning at least twice a week.
11. Tenants must respect the administration of the hostel; talk to the authorities politely, calmly and respectfully.
12. It is forbidden to harm the property of the hostel: damage to furniture, walls, doors, windows and any other equipment of the hostel. The tenant who caused the damage to the property of the hostel bears full liability for this damage.
13. Students are allowed to bring guests only for a specified period of time: from 9:00 to 20:00. It is forbidden to invite people with alcohol/drug intoxication, with an unstable psyche, as well as liu dei with infectious diseases.

14. The tenant is obliged to carefully and carefully use public places: shower, toilet, kitchen, corridors, training room, etc.
16. The tenant must daily refuel the bed, keep the living space clean and in order.
17. The tenant must immediately inform the commandant of all malfunctions.
18. A place in the hostel is provided only for living, its use for commercial, religious and other purposes is prohibited.
19. The tenant is obliged to read information letters placed on the bulletin board in the hostel.
20. The tenant is obliged to carefully use electricity, heating and equipment.
21. The tenant who committed a minor offence in the hostel must provide the administration with a written explanation of this right of violation. He is then required to meet promptly with the disciplinary mission of the Institute to review the circumstances of his offence and decide on the necessary measures.
22. Accommodation in any room other than that in which the tenant is provided with a place according to the accommodation procedure is strictly prohibited.
23. The student is obliged to contact the head of the hostel or the director of the university complex on all issues related to accommodation, which cause difficulties.
