MISSION OF THE EDUCATIONAL PROGRAM 70910205 MASTER'S PROGRAM IN "CARDIOLOGI"

The program aims to prepare competitive, highly qualified master's students within the continuous education system, possessing knowledge that meets international standards and demonstrating high morality and culture.

The vision of the mission is a leading higher education institution based on the principles of an academic healthcare and science system, serving as a center where professionals work together to develop and transmit knowledge about human health. The master's program in specialty 70910205 "Cardiology" unites the efforts of physicians, researchers, faculty, and other specialists who are inspired by the common mission and share the same values—caring for public health.

As the mission constitutes the foundation of the activities and development of the master's program, it has been communicated to all stakeholders, including the academic community, master's students, residents, and physicians. This is implemented through:

- publication on the official website;
- distribution by e-mail to all departments of the Institute;
- informing the teaching staff, graduate students, graduates, and residents;
- posting on the Institute's information boards;
- collaboration with private companies;
- publications in informational booklets, etc.

The Master's educational program was developed collegially and approved at the meeting of the Institute's Council. The mission and vision of the Medical Faculty reflect social responsibility, an understanding of the faculty's purpose and significance in training highly competent specialists for the entire Republic, and align with the primary directions of

Presentation of the mission during international forums, symposiums, and conferences attended by faculty and master's students;

The purpose of the Master's program in the Specialty "Cardiology" (Code 70910205) is to prepare highly qualified, competent, and clinically minded specialists equipped with contemporary knowledge and practical skills in the diagnosis, treatment, prevention, and emergency care of cardiovascular diseases. The program is designed to develop not only professional competencies but also scientific thinking, clinical ethics, an interdisciplinary approach, and social responsibility.

The objectives of postgraduate training are determined taking into account:

- the priority directions for the development of the healthcare system of the Republic of Uzbekistan:
 - international approaches to the education of cardiologists (ESMO, ASCO, WFME);
- pressing cardiological issues of the region (high morbidity and mortality rates, late detection, insufficient screening coverage, and a shortage of personnel in cardiology services).

PROGRAM TARGET OBJECTIVES:

1. Development of clinical and cardiological thinking founded on the principles of

evidence-based medicine and ethics;

- 2. Training specialists capable of delivering qualified and specialized care within multidisciplinary and specialized clinics;
- 3. Enhancement of the scientific research potential of master's students, and their engagement in cardio-epidemiological, clinical-laboratory, and experimental research;
- 4. Ensuring an interdisciplinary and patient-centered approach in the management of cardiology patients;
- 5. Fostering commitment to continuous professional development, and readiness for teaching and research activities;
- 6. Enhancing the role of the cardiologist in prevention, screening, palliative, and rehabilitative care.

CORE VALUES OF THE EDUCATIONAL PROGRAM:

EDUCATION AND SCIENCE:

The educational process is organized according to the principles of outcome-based education and includes:

- modern clinical scenarios and case-based methods;
- simulation training and practical experience at cardiology dispensaries and family outpatient clinics;
 - research and pedagogical practice;
 - interdisciplinary seminars and scientific study groups;
 - individual research projects culminating in the preparation of a master's thesis;
 - participation in conferences and publishing activities.

The research conducted by master's students is focused on solving practical cardiology challenges: advancing screening processes, evaluating interventional and genetic markers, analyzing pharmacological and epidemiological data, and introducing novel approaches to therapy, interventional procedures, and palliative care.

SOCIAL ORIENTATION:

The program considers not only professional and scientific objectives but also social

aspects:

- the healthcare system's demand for cardiology specialists;
- social challenges late diagnosis and low cardiovascular awareness among the population;
 - the need to cultivate social empathy, tolerance, and ethics in physicians;
- enhancing prevention and health education, and participation in WHO programs to reduce cardiovascular mortality.

Thus, the postgraduate education program in Cardiology is designed to prepare a new generation of cardiologists capable of responding to contemporary challenges, implementing scientific advancements into clinical practice, working within multidisciplinary teams, and establishing high standards of professionalism in the interest of the nation's health.

The Andijan State Medical Institute implements its mission not only declaratively but also translates it into concrete strategic, organizational, and educational solutions, including the development and continuous enhancement of postgraduate medical education programs, quality assurance mechanisms, as well as academic and clinical policies.

The mission of the Master's program in the Specialty "Cardiology" 70910205 is developed in close alignment with the Institute's mission and forms an integral part of the overall development strategy of ASMI. INTERACTION WITH STAKEHOLDERS

The mission and development strategy of the program are formulated taking into account the opinions and expectations of various internal and external stakeholders:

- Faculty members participate in the annual review of curricula, including within the framework of departmental and methodological councils;
- Master's students are engaged through regular satisfaction surveys, questionnaires, participation in focus groups, and involvement in student councils;

- Employers (heads of cardiological dispensaries, medical organizations) participate in program development, accept master's students for internships, and take part in final certification;

QUALITY ASSURANCE SYSTEM

 - in departmental protocols regarding the annual updating of content;

 - in self-evaluation reports and development plans.

Thus, the mission of the Institute and the Master's program in Cardiology is not a mere formal declaration, but functions as an effective tool for planning, implementation, monitoring, and sustainable development of the educational program aimed at training competent, ethically mature, and in-demand specialists who meet the contemporary challenges of medicine and

Andijan State Medical Institute has implemented a systematic and cyclical mechanism for reviewing the mission and objectives of the Master's educational program in the Specialty "Cardiology" 70910205, based on the principles of quality, scientific validity, social adaptability, and sustainable development.

The process of mission updating is based on interaction with key stakeholders and is conducted taking into account:

- changes in medical science and international clinical guidelines;
- priorities of state policy in the healthcare sector (Presidential Decrees, and strategies for the development of medicine and education through 2030);
- trends in the socio-economic development of the country and region (for example, increased cardiovascular morbidity, the necessity of telemedicine, and digitalization);

- 2. Annual analysis of changes in the external environment—medical statistics, demographic indicators, epidemiological data, and new challenges (for example, COVID-19);
- 3. Discussion at department meetings, the methodological council, and the Institute Council, involving representatives of the Ministry of Health of the Republic of Uzbekistan and employers;
- 4. Comparative analysis of the missions and objectives of leading foreign universities implementing analogous programs (benchmarking);
- 5. Preparation of recommendations for mission updates, including protocol documentation and approval of amendments by the Institute Council.

EXAMPLES OF ACTUAL REVISION:

- In 2021, the mission was updated to include the principles of evidence-based medicine and a clinical-scientific integrated approach.
- In 2023, priorities reflecting the advancement of genetics in cardiology and interventional cardiology were introduced.
 - In 2024, provisions highlighting the necessity of interdisciplinarity, ethics, and a

strictly patient-centered approach were incorporated.

PRINCIPLES OF REVIEW:

- Regularity (once every three years or as required);
- Openness to proposals from stakeholders;
- Transparency of procedures with mandatory publication of updates;
- Flexibility and adaptability to international and national developments;
- Scientific and ethical justification.

Thus, the Institute ensures the dynamism and relevance of its mission, transforming it into a living instrument of strategic management, educational transformation, and alignment with the expectations of society, the state, and the professional community.
